SUBJECT: MINUTES OF THE PROCURING COMMITTEE MEETING HELD ON 15-07-2020 TO REVIEW BID EVALUATION REPORT FOR CONSTRUCTION OF SCHOOL PKG NO 11-A MEERAN MACHI, QSK.

A meeting of procurement committee, PMIU, SBEP was held on 15-07-2020 under the chairmanship of Deputy Program Director, PMIU, SBEP in the committee room of PMIU to finalize the bid evaluation report for the Package No SBEP-P11A QSK. After the recitation from the Holy Quran and the introduction of the members, the chair asked the procurement officer to brief the committee about the procurement process of the subject bidding. He informed the committee that the sealed Bids for Package No SBEP-P11A QSK, for construction of one de-scoped school GBMS Meeran Machi, Taluka Miro Khan, District Qamber Shadadkot, were invited as SPPRA Rule-17 (2) and Rule-18, under Procedure Single Stage One Envelope Bidding as per SPPRA Rule-46 (1) (a) (b) & (c) & Methods of Procurement adapted NCB SPPRA Rule-15. (1) & (2) (B) (i) (ii) (iii)

2. He further informed the committee that total Three (3) following Bidders participated as against Nine (9) Tender Documents / CD's sold. All three bids were opened on 4th June 2020 at SBEP-PMIU Office at 3pm in the presence of Procurement Committee Members, Bidders representatives, representative of Donner Agency USAID, as Per SPPRA Rule-41 (1) to (9). He informed the members that the following bids were offered.


3. The consultant M/s Halcrow Pakistan also supported in the evaluation of the proposals. The Procuring Agency reviewed and examined jointly by the Engineering Section, Procurement Section of SBEP-PMIU, Technical Experts of Consultant M/s Halcrow Pakistan and found as under:


- 1) All above three participated bidders are found technically disqualified. Also 2nd lowest and 3rd bidders have quoted their financial bids more than 15% as compared to Engineer's Estimated cost.

4. After the detailed deliberation and the recommendation of evaluation committee, the procurement committee decided to cancel the tendering process on the ground that no bidder was financially qualified as per SPPRA Rules and decided to go for re-tendering without further delay.
